



## GRANTS FOR NON-PROFIT ORGANIZATIONS OR INDIVIDUAL ARTISTS

The Nantucket Arts Council assists the innovative efforts of artists, as well as cultural and educational organizations, to create events, programs or organize projects in the visual, performing or literary arts that are beneficial to the Nantucket community.

Application Forms must be completed and submitted by **Monday, April 20, 2020** for consideration.

Forms may be downloaded from our website and returned electronically, mailed or delivered to Nantucket Arts Council, P.O. Box 1276, Nantucket, MA. 02554. Please note our new PO box number and , zipcode. NEW OFFICE LOCATION: Upstairs in the Chamber of Commerce, Zero Main St., Nantucket, MA.

Important information to consider when applying for an NAC grant:

1. Recipients must use the grant for the project in the application. The grant may not be used for any other project and must be completed by one year from the date of application; special applications for longer- term projects may be considered. If the recipient fails to complete the project within the approved time- line, the grant must be returned in full to the Nantucket Arts Council.
2. Recipients must acknowledge NAC grant support in all brochures, advertisements, reports, interviews and articles relevant to the project.
3. Recipients of NAC Grants must provide a written report at the end of the project describing what goals were accomplished by the project, and include pertinent statistics such as attendance, employment, expenses and revenue. Reports must be submitted no later than December 31<sup>st</sup> of the year of the project, and must be submitted before a new application will be considered.
4. NAC Grants may not be used for purchasing buildings or land, operating budgets or deficits, endowments, loans, or sectarian religious or political activities.
